Child Medical/Photo Release

This form is to authorize Synergy Dance Studio, their agents, representatives and employees (hereinafter "the School") to obtain emergency medical assistance and to provide transportation for the child herein below names, and to release the School from liability for injuries to children while on the school premises or otherwise in the care of the school staff members, such as in transporting the children.

The undersigned further agrees to be financially responsible for all such medical services, including the cost of defense and enforcement of this indemnity agreement. I further understand and agree that the School, its agents, representatives, or employees may administer simple first aid in the event of minor injuries, and family members or doctors will be called when in the discretion of the School personnel, if it is deemed necessary.
